How to pay your property taxes

Property taxes are due by December 31st in MO, and 2 times a year in KS.

You should receive a bill from the county to the address listed on the tax files (usually updated when you purchase the property) but if you do not, you can go online and see the amounts due, and make payments, and print a receipt for your records!

• To search by name, enter **Last Name** followed by a space, **First or Partial First Name**, and an * (asterisk).
Examples:
(If you are unable to locate your property and there are multiple owners, try the search again using an alternate owner's name.)
• To search for a **Company or Organization**, enter the **Full or Partial Name** followed by an * (asterisk).

Property Address Search

• **Street Address** must be entered for a Property Address search. Enter **street number** followed by ***street name***.
Example:
• An * (asterisk) may be used in the street number to provide a list of addresses on a block.

(city, state and zip entry fields are optional.)

Or search by your property address here, you only need to end in the top line, like this:
123*Brooklyn* and hit submit

Find your property:

There could be several options pop up, like the below screen shot. You are looking for a property, not 'personal property' which would be someone's vehicles that they have registered at that address (like your tenants).

This is a property, note the 00-00-0000 after the tax ID number. Also check the zip codes, as you can see there are 2 properties with the same address

This is a personal vehicle, you can see the odd tax number on it. Don't pay these!

Pay your taxes: Once you get your correct property (it should have you or your company as the owner, but if it does not, the tax records will update when you pay the bill, or you can call them to update it) then click into it, and it will show you:

Receipts of previous years

Amount owed now

And you can click to make a payment too!

It will load the receipt when you are done, save this, as it is a tax write off for your property!
